1. When garbage is mixed with or contaminated by other harmful substances prohibited from discharge or having different discharge requirements, the more stringent requirements shall apply.

2. Comminuted or ground food wastes must be able to pass through a screen with mesh no larger than 25 mm.

3. The discharge of introduced avian products in the Antarctic area is not permitted unless incinerated, autoclaved or otherwise treated to be made sterile.

4. Offshore platforms located 12 nm from nearest land and associated ships include all fixed or floating platforms engaged in exploration or exploitation or associated processing of seabed mineral resources, and all ships alongside or within 500 m of such platforms.

5. Cargo residues mean only those cargo residues that cannot be recovered using commonly available methods for unloading.

6. Cargo residues, cleaning agents or additives, contained in hold washing water must NOT be Harmful to the Marine Environment (HME) as established based on criteria in Appendix 1 of MARPOL Annex V and declared by the shipper.

A cleaning agent or additive is considered not harmful to the marine environment if it:

- Is not a "harmful substance" in accordance with the criteria in MARPOL Annex III; and
- It does not contain any components which are known to be carcinogenic, mutagenic or reprotoxic (CMR).

**** En-Route refers to ship sailing in a linear passage @ at least 4-6 knots (Not Circling)**

******* In cases of prolonged anchorage and high garbage accumulation (Including Food Wastes), Master to refer to GP A1 for guidance and approach office (TSI/TM) for landing arrangements.

Note: Incinerator operations are prohibited within Port Limits and ECA areas. For Incineration use in port for burning garbage, Port state approval and office approval is mandatory and valid for that Port stay only.
